

Proclamation
No. 936
August 11, 1998

**SUBJECT : Reserving Certain Parcels of Land of
the Public Domain, situated in the City of
Olongapo, Island of Luzon, for the Use of the
City of Olongapo**

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the authority vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from sale, entry, disposition or settlement and reserve for the use of City of Olongapo as municipal building, slaughter house, market, school, hospital and public plaza site purposes, subject to private rights, if any there be, certain parcels of land of the public domain, situated in the City of Olongapo, Island of Luzon, which parcels of land are more particularly described as follows:

- Lot – 2 TS – 308, Case 2 Municipal Site

The aggregate area covered by this proclamation is One Hundred Seventy-Eight Thousand and Ninety-Five (178,095) Square Meters.

This proclamation is subject to the minimum road right of way requirements of the Department of Public Works and Highways pursuant to Executive Order No. 113 as amended by Executive Order No. 621.
