Subject:

Designation of Bacon-Manito Geothermal Airshed and

its Governing Board

Pursuant to Section 8 f of the Philippine Clean Air Act (RA 8749), Sections 1 and 2, Rule XV, Part V of its Implementing Rules and Regulations (DENR Administrative Order 2000-81) and Sections 1,3 and 4 of the Memorandum Circular No. 2002-13, the Bacon-Manito Geothermal Airshed is hereby designated.

Section 1. Coverage of the Airshed

For the purpose of designating the boundaries, the following are the geographic coordinates of the airshed:

Section 2. Review and/or Revision of coverage of the Airshed

Upon consultation with appropriate local government authorities, the Secretary of the Department, upon recommendation of the Bureau shall, from time to time, review, and or revise the designated airshed.

Section 3. Designation of Bacman Geothermal Airshed Governing Board Members

Section 9 of RA 8749 created a Governing Board to effectively carry out the formulated action plan.

The Secretary shall act as Chair of the Board with the Regional Executive Director and the Regional Director of the Environmental Management Bureau as Deputy Chairpersons.

The following are hereby designated as the members of the Board:

- a. The Provincial Governor of Sorsogon
- b. The Provincial Governor of Albay
- c. The City Mayor of Sorsogon and Municipal Mayor of Manito, Albay
- d. The Regional Directors of the following:
 - Department of Transportation and Communication-Land Transportation Office
 - Department of Health
 - 3. Department of Trade and Industry
 - 4. Department of the Interior and Local Government
 - Department of Science and Technology(DOST)
 - 6. Department of Energy
- e. One (1) representative from the steam field developer;
- f. One (1) representative from the geothermal power plant operator;
 and.
- g. Representatives from the private business sector and from the people's organization together with the non-governmental organizations (the number of which shall be 5:2:2 government private – civil society) who shall, within six (6) months from the designation of the airshed, be chosen by and among themselves through sectoral assemblies.

When a vacancy occurs during the term of a member from PO, NGO or Private business sector, a new member shall be appointed by the Governing Board for the remainder of the unfinished term.

Section 4. Functions of the Board

As provided under Section 9 of RA 8749, the board shall perform the following functions:

- a) Formulation of policies;
 - b) Preparation of common action plan;
 - c) Coordination of functions among its member; and,
 - d) Submission and publication of an annual air quality status report for each airshed.

Section 5. Effectivity

This Order shall take effect immediately and shall remain in force unless repealed/revoked in writing.
