DENR ADMINISTRATIVE ORDER

**SUBJECT : REDEFINING THE ADMINISTRATIVE JURISDICTION  
OF THE COMMUNITY ENVIRONMENT AND NATURAL  
RESOURCES OFFICES (CENROs) UNDER PROVINCIAL  
ENVIRONMENT AND NATURAL RESOURCES OFFICE  
(PENRO) CAMARINES SUR**

Pursuant to Executive Order No. 192 and in order to improve the delivery of ENR services to the people of Camarines Sur, the management and supervision of the municipalities and cities within the Province of Camarines Sur is hereby redefined and operationalized following the Congressional District boundaries, to wit :

• **PENR AND CENR OFFICES**

The PENR Officer shall have direct control and supervision of all CENR Offices under his area of responsibility.


- OFFICE OF THE REGIONAL EXECUTIVE DIRECTOR

The Regional Executive Director (RED) shall execute the overall management and supervision of all the Provinces under his area of responsibility.

Likewise, the RED DENR Region V, Legazpi City shall promulgate the necessary operational guidelines in the smooth and efficient transfer of records, properties and accountabilities to the newly-operationalized offices under this Order. Moreover, it must be understood that no additional manpower nor financial cost be entailed in carrying out this Order.

All orders, memoranda and circulars inconsistent herewith are hereby repealed and /or amended accordingly.
